- With reference to the proposal of the Council for the Development of Cambodia.

Hereby Decided

- Article 1: Establish the Sihanoukville Port Special Economic Zone (Sihanoukville Port SEZ), which is located at Mondul 3, Sangkat N°. 3, and Mondul 3, Sangkat N°. 1, Sihanoukville City, Preah Sihanouk Province.
- Article 2: The location of the Sihanoukville Port Special Economic Zone is Six Hundred Seventy Four Thousand and Nine Hundred Thirty Seven square meters in size as shown in the appendix of geographical site and boundary which is approved by the competent ministries attached to this Sub-Decree.
- Article 3: All land areas located in the premise of the Sihanoukville Port Special Economic Zone as determined in Article 2 are privately state-owned property subject to the legitimate domain of Sihanoukville Autonomous Port (PAS).
- Article 4: The organization and functioning of this Special Economic Zone shall be subject to the extent of laws and other regulations of the Kingdom of Cambodia.
- Article 5: The Minister in charge of the Office of Council of Ministers, Minister of Interior, Minister of Economy and Finance, Minister of Land Management, Urban Planning and Construction, Minister of Commerce, Minister of Industry, Mines and Energy, Minister of Labor and Vocational Training, Ministers, Secretaries of State of all Ministries-Institutions concerned, the Governor of Preah Sihanouk Province and Sihanoukville Autonomous Port (PAS) shall undertake to carry out this Sub-Decree with efficiency from this signing date onwards.
